Recommended cleaning instructions for Precontraint® 502, 502 Stripes, 542 Stripes, Stam 6002 –Solids & Stripes, Soltis® 86, 92, 93, 99

- Lay out the fabric on a flat area, Moisten the fabric with clean water. Add a solution of cleaning agent to the fabric, specifically APCO Vinyl Cleaner Plus, a.k.a. APCO Vinyl Cleaner HD
- Brush the fabric using a soft bristle brush with feathered ends and allow the solution to do most of the work, Do Not grind the bristles into the fabric.
- Rinse. Duplicate effort on second side. (A solution of 10% bleach can be brushed onto the fabric to kill any mildew spores that may have remained.)
- Rinse all residue from the solution of 10% bleach. Duplicate effort on second side. Goods should be hung to dry.

Finally an application of APCO Vinyl Protectant should be added to the surface after the 'post-wash' drying time .

- Repeat application on the other side of the fabric. Goods should be hung to dry.
- Reinstall the fabric on its' framework.

10-year limited warranty SOLTIS PROOF 502

Applications: Awnings, canopies, shade sails

Subject to all the terms and conditions contained herein and with specific reference to the percentage of Serge Ferrari liability chart contained herein, Serge FERRARI hereby provides a ten (10) year limited warranty for the products SOLTIS PROOF 502.

1) Compliance with specifications

Serge Ferrari warrants that the product shall at the time of delivery at Serge Ferrari's plant of manufacture, meet all technical specifications stated in the published Serge Ferrari data sheets.

2) Compliance with sustainability & functionality requirements

Serge Ferrari warrants the sustainability & functionality of the concerned membrane. Given the current knowledge, mechanical or aesthetic changes cannot be avoided by use conditions or circumstances environment. The guarantee provided by Serge Ferrari could not be committed in this context and any legal action against it would be null and void.

3) Compliance with our commitments

In the event of default occurring and reported during the warranty period, under normal use and if it can be proved that the defect in the membrane decreases the performance and function of the article made, Serge Ferrari accepts the replacement at its expense the only defective material to the exclusion of any other involvement.

4) Waterproofing

Serge Ferrari warrants that the products shall remain waterproof for a period of 10 (ten) years following the delivery of the product from Serge FERRARI plant of manufacture.
Each of the above described warranties are herein described collectively as the "Limited warranty".

WARRANTY APPLICATION CONDITIONS

The warranty takes effect on the day of delivery of the Serge Ferrari membrane to the customer.

The right to warranty only applies if the imperfections are reported by registered letter with acknowledgement of receipt to Serge Ferrari within a maximum time period of 30 calendar days of their occurrence; the invoice of the goods must also have been fully paid. Failure to notify Serge Ferrari within thirty (30) days following the discovery of any defect shall render this limited warranty null, void and of no legal effect with respect to that particular defect. After notification of an alleged defect, Serge Ferrari shall be entitled to inspect the product in order to take appropriate steps for timely corrective measures. In the event Serge Ferrari representatives are denied the right to inspect the alleged defect, this limited warranty shall be null, void and of no legal effect with respect to such defect. This warranty does not therefore cover the labour costs or those resulting from the disassembling, reassembling and transportation operations. Furthermore, no compensation is provided for under the terms of this warranty.

Under the guarantees described above, and subject to the exclusions hereafter, we will supply the necessary yardage to replace.
